Nakon pregleda i ocjene ponuda u Grupi 3 utvrđeni su razlozi za odbijanje ponude ponuditelja VAGE d.o.o. Koledovčina 2A, 10000 Zagreb, OIB: 30335873024 – U dokumentaciji za nadmetanje tehničke specifikacije nisu popunjene sukladno točki 2.2. dokumentacije za nadmetanje, odnosno tražena širina platformske vage je između 1.300 – 1.600 mm, a ponuđeno je od 1.250 mm što ne zadovoljava tražene tehničke specifikacije. Naručitelj je provjerio sadržaj podnesenih ponuda, uspoređujući ih sa tehničkim specifikacijama i opisom posla, svim relevantnim tehničkim pojedinostima predmeta nabave te je napravio analizu ispunjenja svih propisanih uvjeta nadmetanja.

Slijedom navedenog, a prema zadanom kriteriju odabira, kriteriju najniže cijene, odlučeno je kao u izreci ove Odluke. /

After examination and evaluation tenders of the Lot 3 Contracting Authority identified reasons for the rejection bidder VAGE d.o.o. Koledovčina 2A, 10000 Zagreb, Croatia, Identification/ Registration Number: 30335873024

The Tender documentation, in the part of the technical specifications is not filled in according to section 2.2. of The Tender documentation, i.e. the required width of the platform scale is between 1.300 and 1.600 mm, and Bidder has offered 1.250 mm which does not meet the required technical specifications.

The Contracting Authority has checked the contents of the tenders submitted, comparing them with the technical specifications and terms of reference, all relevant technical details of procurement and has made an analysis of the fulfilment of all prescribed conditions of competition. Based on Contracting Authority request, the most favourable bidders submitted the original certificate of tax administration on the debt.

Consequently, and by default the selection criteria, the criterion of the lowest price, it was decided as in the operative part of this Decision.
